Pension Fund: The Employer agrees to contribute \$3.80 per hour to the Central Laborers Pension Plan, PO Box 1267, Jacksonville, IL 62651-1267 for each hour or portion thereof worked by an employee under this Agreement. Contributions for overtime hours worked to be paid at the applicable overtime rate.

Annuity Fund: The Employer agrees to contribute \$8.00 per hour to Plasterers and Cement Masons Local 18, C/O Quorum, 3101 Greenhead Drive, Suite A, Springfield, IL 62707 for each hour or portion thereof worked by an employee under this Agreement. Contributions for overtime hours worked to be paid at the applicable overtime rate.

Health and Welfare Fund: The Employer agrees to contribute \$5.34 per hour to the Operative Plasterers' and Cement Masons' Health and Welfare Fund for each hour or portion thereof worked by an employee under this Agreement to: Indiana State Council of Plasterers' and Cement Masons' Health and Welfare fund and Pension Fund, PO Box 50440, Indianapolis, IN 46250.

Apprenticeship Fund: The Employer agrees to contribute fifty cents (\$.50) per hour for each hour or portion thereof worked by an employee covered by this Agreement and remit the total of fifty cents (\$.50) to the Joint Apprenticeship and Training Trust Fund along with reporting forms to be furnished by the Trustees.

IAF: The Central Illinois Builders of AGC Industry Advancement fund, hereinafter called I.A.F. shall be financed by payments made by the Employer in the amount of fourteen cents (\$.14) per hour worked by employees covered by this Agreement, which shall be remitted and reported on the same reporting form containing the Plasterers Pension contribution (Central Laborers Pension Fund). The I.A.F. contribution shall be held in trust and the purpose shall be generally to benefit and promote the Building Construction Industry. Provided, however, that no expenditure from said fund shall be made for any activity injurious to the Union.

Working Dues: The Employer agrees to deduct a dues assessment of five percent (5%) per hour of the journeyman wage package (base wage & fringe benefits) from employees who have executed an "Authorization for Check-off" form furnished by the Union. The Employer agrees to forward the dues monies no later than the twentieth (20) day of the following month to the Operative Plasterers' & Cement Masons' Local #18, 400 NE Jefferson, Suite #300, Peoria, IL 61603. Apprentices' deductions will be based upon five (5%) of their current wage package.

Building Trades: The Employer agrees to deduct four cents (\$.04) per hour for each hour or portion thereof worked by an employee covered by this Agreement and remit same to Livingston & McLean County Building Trades, PO Box 3248, Bloomington, IL 61702.


MRFFC: The Employer agrees to contribute five cents (\$.05) per hour for each hour or portion thereof worked by an employee covered by this Agreement to the Midwest Region Foundation for Fair Contracting (MRFFC). The monies shall be paid to the Central Laborers' Pension Fund, Jacksonville, Illinois, along with Pension contributions.

Substance Abuse Fund: Effective May 1, 2007, the Union and the Employer agree to establish and adequately fund a substance abuse consortium. Funding for this consortium will be provided through a three cents (\$.03) per hour Employer contribution and a three cents (\$.03) per hour Employee contribution. Said monies shall be paid to Quorum Consulting Group, 3101 Greenhead Drive, Suite A, Springfield, IL 62711.
