### HEALTH & WELFARE

It is agreed that each Employer shall contribute to the Central Illinois Bricklayers Health & Welfare Program of the Southwest Illinois Bricklayers Health & Welfare Fund the sum of **Seven Dollars and Sixty Cents (\$7.60)** per hour worked for all journeyman and apprentices covered by this Agreement. These remittances shall be made payable to Central Illinois Bricklayers Health & Welfare Program via one check, not later than the fifteenth (15th) day of the month following the month during which the hours are worked. Mail to P.O. Box 40, East Alton, Il 62024.

### **INTERNATIONAL PENSION FUND**

It is agreed that each Employer shall contribute the sum of **One Dollar and Fifty Cents (\$1.50)** per hour for each hour or portion thereof, for which an employee receives pay to the Bricklayers & Trowel trades International Pension Fund. These remittances shall be made payable to Bricklayers International Pension Fund, via one check including the International Pension Plan – PPA, International Dues Check-off, I.M.I. and BACPAC moneys, not later than the fifteenth (15th) day of the month following the month during which the hours are worked. Mail to Bricklayers International Pension Fund, Department 237, Washington, D.C. 20055-0237.

### **INTERNATIONAL PENSION PLAN – PPA**

It is agreed that each Employer shall contribute the sum of **Twenty-three Cents (\$.23)** per hour for each hour or portion thereof, for which an employee receives pay to the Bricklayers & Trowel Trades International Pension Fund. These remittances shall be payable to Bricklayers International Pension Fund, via one check including the Bricklayers & Trowel Trades International Pension Fund, International Dues Check-off, IMI and BACPAC moneys, not later than the fifteenth (15<sup>th</sup>) day of the month following the month during which the hours are worked. Mail to Bricklayers International Pension Fund, Department 237, Washington, D.C. 20055-0237.

### **INTERNATIONAL MASONRY INSTITUTE**

It is agreed that each Employer shall contribute the sum of **Fifty-three Cents (\$.53)** per hour for each hour worked by all employees covered under this Agreement to the International Masonry Institute (I.M.I.). These remittances shall be made payable to Bricklayers International Pension Fund, via one check including the International Pension, International Dues Check-off and BACPAC moneys, not later than the fifteenth (15th) day of the month following the month during which the hours are worked. Mail to Bricklayers International Pension Fund, Department 237, Washington, D.C. 20055-0237.

### **BRICKLAYERS LOCAL #8 OF ILLINOIS PENSION PLAN**

It is agreed that each Employer shall contribute the sum of **Seven Dollars and No Cents (\$7.00)** per hour for each hour worked by all employees covered under this Agreement to the Bricklayers Local #8 of Illinois Pension Plan. Make checks payable to Bricklayers Local #8 Fringe Collection fund, via one check including the Local Dues Check-off and CIB IAF and mail to P.O. Box 6569, Champaign, Il. 61826-6569, not later than the fifteenth (15th) day of the month following the month during which the hours are worked.

### **CIB INDUSTRY ADVANCEMENT FOUNDATION (CIB IAF)**

It is agreed that each Employer shall contribute the sum of **Fourteen Cents (\$.14)** per hour for each hour worked by all employees covered under this Agreement to the CIB IAF. Make checks payable to Bricklayers Local #8 Fringe Collection Fund, via one check including the Local Dues Check-off and Local Pension and mail to P.O. Box 6569, Champaign, Il 61826-6569, not later than the fifteenth (15th) day of the month following the month during which the hours are worked.

**CENTRAL ILLINOIS TROWEL TRADES SUBSTANCE ABUSE PROGRAM**

It is agreed that each Employer shall contribute the sum of **Three Cents (\$.03)** per hour and deduct from each Employee **Three Cents (\$.03)** per hour for each hour worked by all employees covered under this Agreement. Make checks payable as per the wage and benefit form, not later than the fifteenth (15<sup>th</sup>) day of the month following the month during which the hours are worked.


